### Job Description:

The Director of Scientific Development provides support to the Resverlogix team in meeting research and development objectives by contributing to the conduct and monitoring of scientific research studies both internally and externally. - Participate in scientific discussions, data review and setting objectives including providing updates on the status of research and projects (data summaries)
- Review and stay informed of the scientific and clinical landscape in multiple therapeutic areas
- Manage logistics for external research collaborations and projects
- Manage ordering and budgeting (invoices, purchase orders)
- Create and track non-disclosure agreements and contracts

[Resverlogix](#) is a late-stage clinical biotechnology company, located in Calgary, Alberta, dedicated to improving the lives of patients with chronic illnesses. We are developing a new class of epigenetic therapies designed to regulate the expression of disease-causing genes. Our flagship drug, [apabetalone](#), is a first-in-class selective inhibitor of bromodomain and extra-terminal domain (BET) proteins, which aims to improve patients' lives by restoring biological functions back to a healthier state. Due to the extensive role for BET proteins in the human body, apabetalone, can simultaneously target multiple disease-related biological processes while maintaining a well-described safety profile. Apabetalone is currently undergoing clinical evaluation for high-risk cardiovascular disease, COVID-19, and pulmonary arterial hypertension, and is the first therapy of its kind to receive Breakthrough Therapy Designation from the US Food and Drug Administration (FDA).
